

CONTRACT FOR COMMUNITY CALENDAR BETWEEN THE VILLAGE OF GRASS LAKE DOWNTOWN DEVELOPMENT AUTHORITY, VILLAGE OF GRASS LAKE, MICHIGAN AND THE GRASS LAKE CHAMBER OF COMMERCE.

THE CONTRACT made this 13 day of March 2025, by and between the Grass Lake Chamber of Commerce and the Village of Grass Lake Downtown Development Authority, Village of Grass Lake, Michigan.

CONTRACT AGREEMENT

WITNESSETH: That the Contractor and the DDA for the consideration stated herein agree as follows:

WHEREAS: Act 57 of 2018 authorizes a Downtown Development Authority to promote economic development.

WHEREAS: The Downtown Development Authority has determined that a shared community calendar will promote economic development by promoting the events of downtown businesses.

THEREFORE: The Village of Grass Lake Downtown Development Authority does hereby contract with the Grass Lake Chamber of Commerce to provide an online community calendar commencing December 9, 2024 through December 9, 2025.

ARTICLE I SCOPE OF WORK - The Grass Lake Chamber of Commerce will contract with a licensed and insured company to provide a community calendar available to the public in perpetuity.

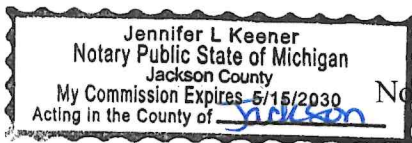
ARTICLE II Permits – The contractor and the Grass Lake Chamber of Commerce will be responsible for completing all necessary applications for permits.

ARTICLE III THE CONTRACT PRICE - The DDA shall pay to the Grass Lake Chamber of Commerce a sum of \$480 per year for the purpose of providing an online community calendar.

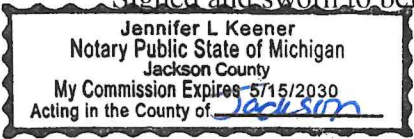
